Kellogg-Atlass Townhouses Renovated and Sold to Bill Bray and Jerry Douglas

Bill Bray is a Purdue grad who has returned to the Lafayette area after receiving his MD from IU Medical School in 1997. A member of the Air Force, Bill was looking for a place to call home. He wanted to live in the city in an established neighborhood, in part, he says because of his desire to be involved in preservation, but also because, as he says "I was influenced a lot by the European way of life and their commitment to their cities."

## Development of North End of North 5<sup>th</sup> Street A VISION

Opportunities for continuing neighborhood revitalization related development have been identified on the north end of North Fifth Street. Specific houses and commercial properties in this area that are known to be for sale, although not necessarily listed, have been identified for

acquisition and redevelopment as owner-occupied urban residences. In 1998 the City of Lafayette included Historic Centennial Neighborhood as a part of the Greater Downtown Neighborhood Revitalization Strategy Area. Such a designation allows the City to use community development block grants in a more flexible way for housing creation. Success stories of this program are the new construction North Fifth Street Brownstones and Rowhouses that were completed in 2000 and the soon to be completed historic rehabilitation of the Kellogg-Atlass Townhouses at 509-511 N. 7th The City's Revitalization Strategy plan Street. encourages high visibility projects such as these, and those contained in the VISION. The VISION in the form of a PowerPoint presentation has been presented to the City of Lafayette Departments of Community Development and Redevelopment, the Neighborhood Action Committee and the Lafayette City Council. We have the ideas; we need funding.

#### Centennial Park to be revamped

HCNA has recently completed a park master plan for the local park. This plan was created with the assistance of the Lafayette parks department and was based on the responses to a survey HCNA conducted last summer of local residences. The master plan was approved by the Lafayette City Park's board with a unanimous vote.

Our new park will feature a reconstructed basketball court with new goals and a smooth A brand new shelter house will be constructed that pays homage to the school that once was in this location. New play pieces for children, which include a swing set and a combination play area with multiple slides and climbing areas, will be installed. These and several smaller play items will greatly expand the opportunities for our neighborhood children to play and enjoy the park. The rusty chain link fence will be replaced with an iron fence that enhances the character of our neighborhood. landscaping, water fountain, grill, adult swings,

and park benches will complete the park redevelopment. All this should be completed by the end of this year or early next year.

Park redevelopment will be paid for by a series of grants: These include but are not limited to grants from the Neighborhood Action Committee (NAC), the Lafayette Park's Department, and the Greater Lafayette Community Foundation. Our gracious thanks go to those organizations that will make our new park a reality.
